

## CLARIFICATION TEXT FOR THE PROTECTION AND PROCESSING OF THE PERSONAL DATA OF THE SUPPLIER CANDIDATE

Your data security is among our top priorities as Nurol Holding Inc (“the Company”). In this context, we would like to provide you the following instructions with regard to the Law Nr. 6698, Protection of the Personal Data (“the Law”).

- 1- **DATA MANAGER:** Your personal data may be processed by the Company in the capacity of data manager in the context explained below and in accordance with the Law. You can access the detailed information about the processing of your personal data by our Company by accessing the publicly shared Nurol Holding Inc. Protection and Processing of the Personal Data from the web address [www.nurol.com.tr](http://www.nurol.com.tr).
- 2- **THE PURPOSE OF PROCESSING YOUR PERSONAL DATA:** Your data collected will be used in accordance with the personal data processing terms and purposes provided in the Articles 5 and 6 of the Law Nr. 6698 according to the following purposes: to help recognize the supplier candidates and suppliers in our Company’s Supplier Portal; to provide all the necessary information to evaluate the supplier candidates and for their evaluation; starting an accounting record for the Suppliers, defining an accounting code, making payments and tracking payments; tracking, controlling and executing every activity regarding the procurement relationship; and to procure legal and commercial protection for the persons who are in a business relationship with our Company, and to define, develop and improve the commercial and business strategies of our Company.
- 3- **PARTIES THAT YOUR PERSONAL DATA ARE TRANSFERRED TO AND TRANSFER PURPOSES:** Your collected data can be transferred to our shareholders, group companies, business partners, public institutions authorized by law and authorized private persons in compliance with the data processing provisions of the Articles 8 and 9 of the Law to fulfill the Purposes.
- 4- **METHOD OF COLLECTING THE PERSONAL DATA AND LEGAL REASON:** Based on legal reasons such as drawing up and executing agreements, establishing, using or protecting a legitimate interest and a right, your personal data is collected to perform the legal requirements defined in the Articles 5 and 6 of the Law and with the purposes defined in this clarification text when you get into contact with our Company through electronic and/or physical mediums such as the supplier portal, fax, shipment, e-mail, phone and open internet sources.
- 5- **YOUR RIGHTS STATED IN THE ARTICLE 11 OF THE LAW AS A PERSONAL DATA OWNER:** We hereby notify you that you have the following rights regarding the Article 11 of the Law:
  - Learning whether your personal data were processed,
  - Requesting relevant information if your data were processed,
  - Learning the purpose of the processing of your personal data and whether they were processed appropriately,
  - Learning the domestic or foreign third parties that your personal data were transferred to,
  - Requesting corrections if your personal data were processed incorrectly or defectively, and requesting that the third parties which received your data to be notified of the process in this context,
  - Requesting your data to be erased or terminated if the reasons for it be processed cease and requesting that the third parties which received your data to be notified of the process in this context even if your data was process according to the provisions of the Law or other relevant laws,
  - Appealing against the results of a situation where the results of an analysis of the exclusively processed data through automated systems prove to be against you,
  - Requesting compensation if your personal data were used illegally and this caused harm to you.

Your applications directed towards your rights listed above can be communicated to our Company through filling out the Nurol Holding Inc. Data Owner Application Form which can be accessed by [www.nurol.com.tr](http://www.nurol.com.tr). Depending on the nature of your request, your request will be finalized as soon as possible or at a maximum of thirty days without any charges. However, if this process requires any additional charges, you may be charged a fee according to a tariff determined by the Committee for the Protection of Personal Data. By accepting this text, the Supplier is acknowledging that the personal data entered in the portal will be collected, processed and transferred for the purposes defined in this Clarification Text.
